### Apply for Canada Emergency Response Benefit (CERB) with CRA

The CERB supports Canadians by providing financial support to unemployed and self-employed Canadians who are directly affected by COVID-19. It provides up to \$2,000 for a 4-week period (the same as ESDC's weekly pay up to 16 weeks). After you apply, you should get your payment in 3 business days if you signed up for direct deposit. If you haven't, you should get it in about 10 business days.

**Do not apply for the CERB if you have already applied for EI**  
If you have not already applied for EI, you can apply for the CERB. You can do this with the CRA or with Service Canada, but not both. The answers you provide to a few simple questions will help us direct you to the service option that best fits your situation.
